COVID-19 (Coronavirus) Guideline

| Consideration: | Travel controls, social distancing, mass gatherings & general meeting attendance controls, health controls, working remotely, personal hygiene practices |

These guidelines are based on directives issued by the Australian and New Zealand Governments, and their associated health authorities. Such directives take precedent in the event that these guidelines are incomplete or at odds with the government directives.

1.0 Business Air Travel Controls

- All international travel is suspended.
- Domestic air travel is restricted to essential travel and approval must be given by relevant Senior Manager.

2.0 Social Distancing, Mass Gatherings and General Meeting Attendance Controls

- Employees may only have business-critical visitors and / or contractors attend sites.
- Only essential employee meetings and training should be held on sites. Use of Skype / Teams is the method to use for meetings to avoid person to person contact.
- Employees should make use of teleconference or videoconference as an alternative to meeting in person.
- Employees should consider limiting meeting attendees, limiting enclosed space meetings to less than 2 hours and maintain distance (e.g. spread employees out where possible).
- Limit the number of people in a meeting room and select the largest meeting room available. No meeting of more than 10 people is allowed in person.

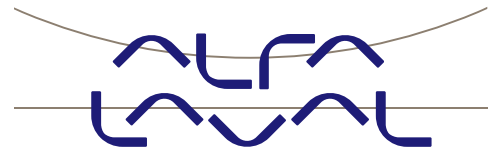
External Meetings and Gatherings:

- External face-to-face meetings shall be kept to a minimum. Use Skype, phones and email for contact.
- Any external training and/or conference attendance must be approved MD.

Internal:

- Employees are encouraged to continue to work in their "base" location and limit travel to other sites unless their role requires them to attend other sites in person or it is business critical to attend the other site in person. If you can work from home, you should.
- Communal events such as birthday celebrations, team morning teas and lunches are suspended.

3.0 Health Controls

Employees

- Any employee exhibiting **flu-like symptoms (in the last 48 hours)** must **NOT** attend the workplace, and should seek medical advice as per local health authority guidelines. When returning to the workplace after recovery (and showing no symptoms for last 48 hours), employees shall contact their manager. An Employee Health Declaration Form shall be completed prior to returning to the workplace.
- Any employee who is a **confirmed case** of COVID-19 (coronavirus), must self-isolate for at least 14 days. A medical clearance must be obtained prior to returning to the workplace.
- Any employee who has been in **close contact** with a **confirmed case** of COVID-19 (coronavirus), must self-isolate for 14 days after the date of last contact with the confirmed case. When returning to the workplace after isolation, the employee shall contact their manager. An **Employee Health Declaration Form** shall be completed prior to returning to the workplace in the absence of a medical clearance.
- Any employee who has **returned from any overseas destination** must self-isolate for 14 days from the time of arrival. When returning to the workplace after isolation, employees shall contact their manager. An **Employee Health Declaration Form** shall be completed prior to returning to the workplace.
- Any employee who has been in **close contact** with persons who have **returned from any overseas destination** within the last 14 days, must immediately notify their manager, **NOT** attend the workplace and complete the **Employee Health Declaration Form**. HR, and Department Managers shall make a risk-based decision on a case-by-case basis to determine if a period of self-isolation from the workplace is required.
- Any employee who, within the last 14 days, has been in **close contact** or living with persons showing **flu like symptoms**, must immediately notify their manager, **NOT** attend the workplace and complete the **Employee Health Declaration Form**. HR, and Department Managers shall make a risk-based decision on a case-by-case basis to determine if a period of self-isolation from the workplace is required.
- All hygiene measures have been elevated to follow the advice of relevant health authorities and we are increasing the frequency of cleaning of high-touch surfaces;
- Strict procedures are in place to manage any health concerns at a site level

Visitors & Contractors

- Visitors or contractors exhibiting **flu-like symptoms (in the last 48 hours)** are **not permitted** to enter Alfa Laval Oceania offices or sites.
- Visitors or contractors who are a **confirmed case** of COVID-19 (coronavirus) are **not permitted** to enter Alfa Laval Oceania offices or sites.
- Visitors or contractors who have been in **close contact** with a **confirmed case** of COVID-19 (coronavirus) in the last 14 days are **not permitted** to enter Alfa Laval Oceania offices or sites.
- Visitors or contractors who have **returned from any overseas destination** or been in close contact with anyone who has returned from any overseas location in the last 14 days are not permitted to enter Alfa Laval Oceania offices or sites.
- Visitors or contractors, who, in the last 14 days, have been in **close contact** or living with persons showing **flu-like symptoms** are **not permitted** to enter Alfa Laval Oceania offices or sites.
- All visitors or contractors who are required to attend an Alfa Laval Oceania office or site, must complete a Visitor/Contractor Health Declaration Form before being granted access.
- Courier and delivery persons (with less than 15 minutes of face-to-face contact at site) may not be required to complete a Visitor/Contractor Health Declaration Form This will be risk assessed on a case- by-case basis.
- In business-critical situations, HR and Department Managers may make a risk- based decision on a case-by-case basis to approve a visitor or contractor access to site.
- Approval for the invitation of international visitors or contractors must be given by the relevant Alfa Laval Oceania management team members. It is the responsibility of those arranging visitors and contractors to ensure Alfa Laval requirements are followed.

Working Remotely (alternate locations, working from home, etc.)

- Employees who are required to self-isolate, if fit for work, may be able to work remotely with their manager's approval.
- Other than the specific requirements relating to self-isolation outlined in this Guideline, working remotely requires prior approval by the relevant manager.
- It is the responsibility of the employee to ensure the remote workspace meets local, corporate HR working at home and/or teleworking policies.

Personal Hygiene Practices

Persons should take general personal precautions such as frequent hand washing and hand sanitiser use and using appropriate coughing and sneezing technique. Try not to touch your eyes, nose or mouth and isolate yourself if you feel sick.

Hand washing:

Wash your hands often with soap and running water (for at least 20 seconds) and dry with paper towel or hand dryer, especially:

- After coughing or sneezing
- Before, during or after preparing food
- Before and after eating
- After toilet use
- When hands are visibly dirty
- After handling animals or animal waste.

Hand sanitiser:

If your hands are not visibly dirty, frequently clean them by using alcohol-based hand rub or soap and water.

Coughing & Sneezing technique:

When coughing or sneezing:

- Cover mouth and nose with tissue.
- If you don't have a tissue cough or sneeze into your upper sleeve or flexed elbow.
- Dispose of tissue into closed bin immediately after use.
- Clean hands with alcohol-based hand run or soap and water after coughing or sneezing.

| COVID-19 (Coronavirus) | <p>Coronaviruses are a large family of viruses which may cause illness in animals or humans.</p> <p>The most recently discovered coronavirus causes coronavirus disease COVID-19. Some coronaviruses can cause illness similar to the common cold and others can cause more serious diseases, including Severe Acute Respiratory Syndrome (SARS) and Middle East respiratory syndrome (MERS). This new coronavirus originated in Hubei Province, China and the disease outbreak is named COVID-19. It can cause an infection in people, including a severe respiratory illness.</p> |
| Close Contact | 15 minutes or more face-to-face (within 1.5 metres) contact with a person or being in a confined space with a person for 2 hours or more. |
| Flu-like Symptoms (mild to severe) | <ul style="list-style-type: none">• Common COVID-19 or flu-like symptoms include: fever, cough (usually dry).• Sometimes COVID-19 or flu-like symptoms include: fatigue, aches and pains, sore throat, headaches, shortness of breath.• Rare COVID-19 or flu-like symptoms include: runny or stuffy nose, diarrhoea. <p><i>Reference: WHO, Centres for Disease Control and Prevention</i></p> |
